The 2019 Annual Meeting of Shareholders of Kaman Corporation will be held at the corporate headquarters of the Company located at 1332 Blue Hills Avenue, Bloomfield, Connecticut 06002, at 9:00 a.m., local time, on Wednesday, April 17, 2019.

Proposals to be voted on at the meeting are listed below along with the Board of Directors' recommendations.

The Board of Directors recommend a vote **FOR** all the nominees listed and **FOR** Proposals 2-6:

- To elect three Class II directors:
  - 01 - Neal J. Keating
  - 02 - Scott E. Kuechle
  - 03 - Jennifer M. Pollino
- To conduct an advisory vote to approve the compensation of the Company's named executive officers;
- To approve an amendment to the Company's Amended and Restated Certificate of Incorporation eliminating the supermajority voting provisions set forth therein;
- To approve an amendment to the Company's Amended and Restated Certificate of Incorporation providing for the election of directors by majority vote;
- To approve an amendment to the Company's Amended and Restated Certificate of Incorporation declassifying the Board of Directors;
- To ratify the appointment of PricewaterhouseCoopers LLP as the Company's independent registered public accounting firm; and
- To transact such other business as may properly come before the meeting.
