Dear Shareholder:

The Annual Meeting of Kaman Corporation's Shareholders will be held at Kaman Corporation, 1332 Blue Hills Avenue, Bloomfield, CT 06002, on Wednesday, April 19, 2017, at 9:00 a.m., local time, for the following purposes:

Proposals to be considered at the Annual Meeting:

- (1) To elect three (3) Class III directors to serve for terms of three (3) years each and until their successors are duly elected and qualify;
- (2) To conduct an advisory vote to approve the compensation of the Company's named executive officers;
- (3) To conduct an advisory vote to recommend the frequency of future advisory shareholder votes on executive compensation;
- (4) To approve an amendment to the Company's Amended and Restated Certificate of Incorporation declassifying the Board of Directors;
- (5) To ratify the appointment of PricewaterhouseCoopers LLP as the company's independent registered public accounting firm; and
- (6) To transact such other business as may properly come before the meeting.

**The Board of Directors recommends a vote "FOR" all nominees, "FOR" Proposals 2, 4 and 5, and "1 YEAR" for Proposal 3.**

These items of business are more fully described in the Company's 2017 Proxy Statement. The close of business on February 10, 2017 has been fixed as the record date (the "Record Date") for the determination of shareholders entitled to receive notice of and to vote at the Annual Meeting or any adjournment(s) or postponement(s) thereof.

Shareholders of record as of the Record Date are encouraged and cordially invited to attend the Annual Meeting. Directions to attend the Annual Meeting where you may vote in person can be found on our website, [www.kaman.com](http://www.kaman.com).
